Associate Members

Companies that provide a product or service in the Ready Mixed Concrete and Cement Producer Industries, divided into two categories, noted below. Dues shall be pro-rated for the current calendar year and paid in full upon joining. In subsequent years, dues will be payable on or before January 15.

Tier 1: Suppliers and Vendors (Fly Ash, Fibers, Slag, Color, Aggregate/Sand, Admixtures, Truck Manufacturers)-
\$1,000 annual dues

Tier 2: Plants, Equipment, Electronic Plant and Monitors, Truck Maintenance, Fuel, Tires, Lubricants, ICF Manufacturers, Concrete Pumpers, Contractors, Municipalities, ICF installers, Mechanics, CPAs, Attorneys, Insurance firms, Computer services, Testing labs, Architects, Engineers, Consulting services, Safety, Project management, Related associations and others as identified.

\$500 annual dues

Other Associate Members and annual dues will be considered on a case-by-case basis and is at the discretion of the URMCA Board.
